Board of Directors Update

Your Egg Farmers of Alberta (EFA) Board would like to thank their fellow producers and the EFA staff for making our January regional meetings a success. There was a fantastic turnout and great atmosphere at all three locations. The structure of the meetings, and the importance of the information being provided, helped create a more relaxed environment that allowed producers to stay focused and engaged.

The EFA Board was pleased to announce a 5.61% quota allocation, effective December 29, 2013, which producers are very happy with. The EFA Board encourages all producers to place their newly allocated birds, to help fill provincial demand with more local production. Producers must notify EFA about your plans for this quota before June 30, 2014, and the quota must be placed by June 30, 2015. This allocation will ensure that Alberta egg farmers can provide even more Albertans with a stable supply of fresh, high quality, locally produced eggs and egg products.

EFA is preparing for its 45th Annual General Meeting (AGM), which is being held on Tuesday, February 25, in Red Deer, Alberta. EFA looks forward to a large turnout of egg farmers, industry and government representatives. Following a review of EFA's Annual Report, elections will be held for 2 positions on the EFA Board of Directors.

The afternoon session, "Navigating the New Reality", will be chaired by Lorna Baird (Executive Director, AFAC) and will include presentations by Geraldine Auston (Ag & Food Exchange), Floyd Mullaney (security advisor) and Kay Johnson Smith (President and CEO, Animal Agriculture Alliance). These fantastic presenters will share insights into the consumers' evolving quest to learn more about the food they eat and where it comes from, as well as the sometimes ruthless world of animal activism.

EFA is also holding a producer meeting on Monday, February 24, which will include updates from CEIRA and the Pullet Growers of Canada, as well as a more detailed overview of EFA's 2014 initiatives.

EFA would like to remind producers and honored guests that pre-registration is required for our AGM this year. In addition, EFA reserves the right to refuse registration and/or entry. We are excited about this year's event and hope to see you there!

Field Statistics Update

The final 2013 numbers are in for our on-farm program evaluations. Alberta's egg farmers have once again demonstrated that providing safe, high quality eggs from hens raised with the highest standards of animal care is our industry's top priority! Here are the 2013 results for the Start Clean – Stay Clean (SC-SC) and Animal Care Program (ACP) evaluations:

- 157 SC-SC layer evaluations were completed in 2013
 - ✓ Alberta's average score: 98.97%
 - ✓ 70 Alberta farmers scored a perfect 100% rating
- 157 ACP evaluations were completed in 2013
 - ✓ Alberta's average score: 98.59%
 - ✓ 101 Alberta farmers have scored a perfect 100% rating
- 118 SC-SC pullet evaluations were completed in 2013
 - ✓ Alberta's average score: 98.12%
 - ✓ 65 Alberta farmers have scored a perfect 100% rating

EFA would like to thank all our farmers for their commitment and hard work every day, ensuring that fresh, local eggs are produced humanely!

EGG FARMING BEST PRACTICE

Please be sure to use the new Pharmaceutical Record, since this is now required under the SC-SC Layer program. This record is for any vitamins or medications that are administered to a layer flock from the time they are 19 weeks of age, until the end of their lay cycle. If you are using vitamins such as Vitamin D on a regular basis, record the detailed information on the product in your Pharmaceutical Record once, then reference where you track the dates that the vitamin is administered (ie: "Dates are recorded on SC-SC calendar"). If you need a copy of the new Pharmaceutical Record form, you can find it on the producer website under the 'SC-SC Layer' page, obtain a copy from your EFA Field Coordinator, or contact the EFA office.

BIO-SECURITY TIP

Ensure that delivery and pickup vehicles and personnel entering the Controlled Access Zone (CAZ) and/or Restricted Area (RA) follow the farm's specific bio-security protocol.

Accreditation in the SC-SC Pullet Program

EFA would like to see more producers obtain their SC-SC Pullet accreditation in 2014. In 2013, 65 producers scored 100% in the program and many more scored in the high 90% range, but only 32 pullet producers have their SC-SC Pullet accreditation. To obtain accreditation, producers must complete the SC-SC Pullet Part 3 audit, which can be requested from your EFC Field Inspector. There are a few records that producers will need to have in place for Part 3, which are not required for Parts 1 or 2. To be prepared for a successful audit, producers should have the following ready:

- Water treatment record
- Mortality record
- Record of ongoing sanitation activities
- Corrective action log
- Farm and barn schematics (map)
- A copy of the SC-SC Pullet producer manual

EFA's goal is to double the number of SC-SC Pullet accreditations in Alberta by the end of 2014 – you can help us reach this goal!

SC-SC Corrective Action Reminders

When the EFC inspector completes your SC-SC evaluations, take the time to review any Corrective Action Requests (CARs) that are issued. These CARs identify areas where you can improve your on-farm safety practices and, if addressed, you can receive points back on your assessment. When reviewing your CARs, be sure to note the agreed upon date by which you must have your CARs completed by, in order to get points back. If your CAR cannot be completed by that date, please contact Dave Lastiwka at the EFA office, to request an extension. If the CARs are not completed by the agreed upon date and no extension has been requested, the lost points will not be returned.

The most common CARs in 2013 were:

- 1) Change footwear, or use foot dips or spray disinfectant on footwear between different age lay facilities in the same production unit
- 2) All-in/all-out in each production unit (barn)
- 3) All-in/all-out program followed by each laying facility (no topping up)
- 4) Only one kind of poultry maintained on the farm
- 5) Record of annual test for total coliforms and fecal coliforms required

Environmental Farming

A key finding of the Life Cycle Analysis completed last year was that feed production is the main contributor to the environmental footprint of egg production in Alberta (ranging from 69 to 99% of the total depending on the impact category evaluated). Optimizing feed efficiency is therefore a key factor to reducing the environmental footprint of egg production (and a key factor toward economical production!). Feed is one of the major contributors to cost, nevertheless, it is clear that feed efficiency and feed conversion ratios vary significantly between farms.

As EFA is dedicated to encouraging the adoption of best management practices, we are beginning to investigate effective strategies to assist producers in lowering or maintaining input costs while understanding their individual carbon footprints. As a first step, we are looking at engaging nutritionists to begin the dialogue around challenges and opportunities. We are also working with Alberta Agriculture to develop a multi-criteria decision analysis (MCDA) model for improved business evaluation of economic and environmental performance. MCDA identifies the optimal combination of feed ingredients that satisfies nutritional requirements of the bird at the lowest possible cost and the minimum environmental impact. Stay tuned for updates!

CEIRA Renewal

The 3-year CEIRA subscription period expires on July 31, 2014. Unless a subscriber advises of their intention to end their CEIRA participation, subscribers will automatically be renewed for the next term, which is a 4-year period from August 1, 2014 to July 31, 2018. CEIRA subscribership is a requirement of quota license for registered egg producers in Alberta.

Calgary CO-OP AGM

At the 2013 Calgary CO-OP AGM, a motion was passed that called for Calgary CO-OP to phase-out eggs from hens raised in conventional cages, within 5 years (please see the April 2013 issue of *EggNotes* for a full recap). This issue will likely be up for discussion once again at their 2014 AGM, which is scheduled for March 10th at the Carriage House Inn in Calgary.

EFA believes in the importance of choice, both for egg farmers and consumers. Calgary CO-OP shoppers already have a wide variety of fresh, locally produced eggs to choose from, including many alternative egg products (ie: free-run, free-range, organic and furnished), as do all Albertans, regardless of where they do their grocery shopping. Any policy decision should be in the best interest of all stakeholders, including both consumers and egg farmers, who are dedicated to providing high quality animal care regardless of the housing system they use to raise their hens

EFA encourages any producers who are registered members of Calgary CO-OP to attend their AGM, to represent and potentially speak on behalf of Alberta's egg industry. Please contact the EFA office if you would like to receive any training or quick tips to help ensure your voice is heard!

ALBERTA EGG MARKET UPDATE

The Nielson preliminary retail sales data is available up to January 11th, 2014 and indicates that in the latest 4-week period, 3.0 million dozen eggs were sold in Alberta; a 5.1% increase from the previous 4-week period (ending Dec. 14th) and a 3.1% increase in sales compared to the same period in 2013.

Nielson retail sales in the last 52 weeks are up 3.3% over the previous 52 weeks in Alberta, to 34.6 million dozen eggs! Specialty eggs (excluding Omega-3 eggs) have seen the largest sales growth in the last 52 weeks in Alberta; a 13.6% increase over the previous 52 weeks, to 2.0 million dozen eggs (5.8% of the total eggs sold in Alberta).

Feature Recipe: BROCCOLI CORN QUICHE



Makes: 6 servings • Preparation: 20 minutes • Cooking: 60 minutes

INGREDIENTS:

- 1 tbsp (15 mL) cooking oil
- ½ cup (125 mL) onion, chopped
- 2 cups (500 mL) broccoli florets, chopped (or frozen, thawed)
- 1 cup (250 mL) kernel corn, fresh (or frozen, thawed)
- 1 unbaked 9" (22 cm) pie shell
- 1 cup (250 mL) sharp cheddar cheese, grated
- 2 oz (57 mL) jar of sliced pimiento, drained, chopped
- 3 large eggs
- 1 tbsp (15 mL) all purpose flour
- ½ tsp (2 mL) salt
- ¼ tsp (1 mL) pepper
- 1 ¼ cups (300 mL) skim evaporated milk
- 1 tsp (5 mL) dill weed


DIRECTIONS:

- 1) Heat cooking oil in large frying pan on medium heat.
- 2) Add onion and cook for 5-10 minutes, stirring often, until softened.
- 3) Add broccoli and corn and cook for 3 minutes, stirring occasionally, until broccoli is tender-crisp, then cool.
- 4) Spoon into pie shell and spread evenly.
- 5) Sprinkle with cheese and pimiento.
- 6) Beat eggs, flour, salt and pepper with whisk in medium bowl until smooth.
- 7) Add evaporated milk and dill weed.
- 8) Beat well and pour over cheese.
- 9) Bake on bottom rack in 350° F (175° C) oven for 50-60 minutes, until knife inserted in centre comes out clean.
- 10) Let stand for 10 minutes before serving.
