## *New Research Outcomes Videos*

There are two new research outcomes videos available on the producer portal. Both videos are on projects funded by Egg Farmers of Alberta. In the first video, researcher Dr. Clover Bench and her PhD student Emily DePaoli present their findings on the Use of 3D Kinematics, DXA, and Genomics to Evaluate Perching in Commercial Strains of Enriched-Housing Laying Hens. What strain of laying hen do you think might be best suited for enriched housing systems? Find out in this video!



The second video is on Long Lived Layers – An Environmental, Economic, and Animal Welfare Cost/Benefit Analysis. This video features researchers Dr. Nathan Pelletier and Dr. Maurice Doyon and their students Vivek Arulnathan, Ian Turner, and Ousmane Traore walking you through the environmental and economic trade offs of extending layer flock cycles. Did you know the economically optimal cycle length is 71 weeks long meanwhile extending flock cycles over 53 weeks demonstrates an increase in environmental impacts per tonne of eggs?

## *On-Farm Climate Action Fund Applications Open*

The On-Farm Climate Action Fund (OFACF) which will be delivered by Results Driven Agriculture Research has opened for funding applications until March 31, 2025.

OFCAF supports adopting beneficial management practices (BMPs) that reduce greenhouse gas emissions while fostering economic and environmental sustainability. A single farm is eligible for up to \$75,000 to facilitate on-farm BMPs in the areas of:

- Nitrogen management
- Cover cropping
- Rotational grazing practices

## ***Workers Compensation Board Yearly Statistics - 2023***

The Workers Compensation Board has released their 2023 annual statistics on the number of claims, types of injuries, cost of compensation etc. for the Alberta poultry and egg sector. There were 8 claims in 2023 vs. 7 in 2022. The results for 2023 indicated that the highest incident of injury was from either coming into contact with or being struck by an object or equipment with injuries being predominantly sustained to the hands and fingers. ## CO2 Monitor Calibration

AgSafe Alberta has created an in-depth bulletin on “Gas Monitors & Common Agricultural Gases”, which provides valuable information on different types of hazardous gases, different types of gas monitors and calibration of monitors. ### CALIBRATION CHECK

*A calibration check verifies that the sensor(s) and alarms on a personal gas monitor respond within the manufacturer's acceptable limits by exposing it to a test gas. During a calibration check, the user will compare the test gas concentration to the reading on the personal gas monitor. If the results are found to be within the manufacturer's acceptable limits, the calibration check has verified the gas monitor's accuracy. If the calibration check results are not found to be within the manufacturer's acceptable limits, a full calibration will need to be performed.*

### FULL CALIBRATION

*A full calibration is a process that adjusts a personal or portable gas monitor's reading to coincide with the known concentrations of zero and span gases.*

*This results in two steps:*

- 1. Zero calibration, sometimes called zero suppression, is where the personal gas monitor is exposed to the ambient or “zero grade” air. Each sensor registers to zero and the O2 sensor is calibrated to a value of 20.9%.*
- 2. Span calibration is where each sensor expects to be exposed to a known concentration of gas. As each sensor calibrates, the personal gas monitor adjusts to the calibration gas and known values if needed to ensure that the gas concentration values are accurately registered and displayed.*

*It is important to note that if a sensor has degraded beyond an acceptable level, it will have reached its End-Of-Life and will no longer pass a calibration. Any servicing that is performed, such as the replacement of sensors, must be performed as per the manufacturer's instructions and by a qualified person.*

## New Research Summaries

Egg Nutrition Center conducted a study examining the association between egg consumption and cardiometabolic risk factors in adults. The study demonstrated that regular egg consumption as part of a healthy diet had long-term beneficial effects on blood pressure and glucose metabolism and lowered the long-term risks of high blood pressure and diabetes. Additionally, Egg Farmers of Canada has also released a research summary on minimizing the effects of Infectious Bronchitis Virus (IBV) on egg production and egg quality. The researchers advise that a combination of live and attenuated vaccines should be applied pre lay to induce protection against different IBV strains.
