Board Update

Your Egg Farmers of Alberta (EFA) Board of Directors would like to thank producers for another successful round of regional meetings. Your feedback is invaluable when determining which issues require further discussion, which topics can proceed forward, and what our priority areas of focus should be at EFA's upcoming strategic planning session. It is vital for the Board to keep our finger on the pulse of Alberta egg farmers, and understand what successes and challenges producers are dealing with at the grassroots level.

The Board would also like to thank all those producers who took the time to complete and submit their annual EFA Customer Service Survey. The EFA Board and staff are in the process or reviewing the results and determining what actions can potentially be taken to further strengthen EFA's ability to effectively serve the province's egg farmers.

Finally, if you have not already done so, the Board would like to encourage our fellow egg farmers to complete and submit their Producer Community Engagement Survey. This survey is a critical piece of EFA's sustainability strategy, specifically around demonstrating our commitment to the pledge about egg farming families positively contributing to the sustainability of communities across Alberta.

EFC Board Update

The Egg Farmers of Canada (EFC) Board of Directors approved the revised Federal-Provincial-Territorial Agreement (FPTA) at their most recent Board meeting.

Results Driven Agriculture Research Roundup 2023

On June 8th, Results Driven Agriculture Research (RDAR) had their second annual Roundup meeting at the Telus Spark Science Centre in Calgary. The gathering had over 200 participants from various agriculture sectors including a representative from Egg Farmers of Alberta. This meeting provided an excellent networking opportunity and served to provide an update on next steps for funding in agriculture research. RDAR reported there are currently 230 active projects with an additional 42 projects which have been completed. RDAR continues to focus on supporting research that provides solid knowledge translation plans and fuels on-farm adoption. Egg Farmers of Alberta looks forward to continuing to engage with RDAR and the other industry members for future producer led projects.









June Regional Meeting on the Portal

Did you miss attending the June regional meetings? We now have the recorded Calgary regional meeting video up on the Producer Portal available to watch. Visit the portal, click Information Centre, then Producer Meetings to watch the recording.

Portal Feature – Corrective Action Request (CAR) Closure Submissions

On the producer portal under Farm Programs -> CARS, producers can now see their CAR closure letters (which show current program scores), historical CARs, and current CARs. A new feature is that if you have a correction action for your Animal Care or Start-Clean Stay-Clean® program that has not yet been closed, you can submit your documentation to close the CAR on the portal.

Click the edit button on an open/outstanding CAR:



You can then add documentation in support of the CAR closure:



If you click on "add new document" and then "Flag for EFA Review = yes" when you click on submit, it will trigger an email to EFA with the document attached. In the portal, you will then be able to see when it has moved from "outstanding" to "historical" (closed).

Farm Safety Workshops - That's a wrap!

On July 5th, EFA and AgSafe Alberta hosted the final farm safety workshop in Grande Prairie. That wraps up a series of workshops throughout June and July in Lethbridge, Calgary, Edmonton, and Grande Prairie. We would like to thank all farmers who participated – the engagement and discussion was fantastic, and you demonstrated exemplary leadership and dedication!



Farmers who attended the workshops noted they would implement practical changes on their farm such as:

- · Upgrading their first aid kit
- · Investigating the purchase of AED units
- Ensuring they have different fire extinguishers for different purposes
- Creating a barn map with emergency supplies and exits noted
- Adding additional job tasks to their Job Task Hazard Assessments such as outdoor yard maintenance, vaccinations, and using the egg lift
- Using WHMIS labels on products that have been transferred into non-original containers

As a friendly reminder, the revised Farm Safety assessment asks that all of the people performing work in the egg facility have completed a general WHMIS course that has been documented. If you do not already have documented WHMIS training, you can complete it for free at https://www.agsafeabseed.ca/course/whmis-2015-pesticide-veterinary-drug-and-medicated-feed-awareness-course

Use the code EFA2023.



A Refresher on Masks

Did you know? In a study for the Coalition for Sustainable Egg Supply, egg barn workers who wore a mask more than 70 percent of the time had significantly better lung airflow. The combination of dust and ammonia can work in synergy to impair lung function - prolonged exposure without respiratory protection may lead to respiratory health problems, such as chronic bronchitis, wheezing and reduced lung function.



Did you know? When wearing a respirator, there are different reusable filters and/or cartridges depending on the respiratory hazard(s) you are being exposed to. When selecting a cartridge, it is important to consider if you are being exposed to dust, ammonia, pesticides, or other hazardous materials and whether what you are wearing is approved for that exposure.

Resources and Example

To assist egg farmers in selecting the appropriate type of respirator for the factors and conditions present on your farm, EFA has posted reference charts and selection guides from major suppliers (3M and Honeywell) on the Producer Portal. You can find the documents by navigating to Learning and Education -> Farm Resources and Documents and searching for "mask".

One farmer we spoke to who sources 3M masks from Gregg Distributors uses the more expensive specialized masks for specific activities and cheaper ones for daily dust exposure. For example, they use:

- PK/2 P95 filters for bird walks, mortality checks, etc;
- PK/2 P100 filters for more extreme dust (ex. barn blow down, feed mill cleanup, etc.);
- PK/2 MG/OV cartridges for gas and vapours such as ammonia, painting, mixing chlorine dioxide, etc.

It is always a good idea to discuss your individual needs with your manufacturer/supplier.

"Ask the Expert" Forum on the Producer Portal

As noted in the March issue of EggNotes, there is a new section on the Producer Portal Forum: Water Issues and Treatment.

This is a place to discuss water testing, treatment, and other water-related challenges or solutions. The thread is monitored by Dr. Mohammad Afrouziyeh from the Poultry Innovation Partnership (PIP).

All producers who shared a water expert contact or posted a water treatment question on the forum prior to June 30th were entered into a draw to win a water ORP and pH meter. **Congratulations to Steve Kleinsasser from Jenner Colony who won the draw!** Thanks to all producers who submitted excellent questions – we encourage you to view the replies from Dr. Afrouziyeh and to continue to post your egg-cellent questions about water as they arise.

Water Record Keeping Template

EFA has developed an optional template to assist producers who wish to keep track of pH, chlorine, peroxide residual levels, mineral levels, etc. The template also has a guide to conducting and interpreting water tests, including acceptable levels. It can be accessed on the Producer Portal at Learning & Education -> Producer resources and documents (search "water test template").



PIP Water App Release


The Poultry Innovation Partnership (PIP) water app has officially been released! It is accessible through http://pippoultrywaterapp.com/.

The app helps you to assess water quality-related risks and provides a customized risk mitigation report for your farm's unique requirements. The decision tree format gathers information about water through some questions. Based on the answers provided, recommendations are generated in each section, indicating what actions should be implemented. The protocols section links users to water quality information prepared by industry experts and video protocols on water management on poultry farms.

As a result of EFA's sponsorship of PIP, the water app is available to registered Alberta egg producers for free. You will need to click on the "App Access" icon on the top right of the page, and on the new page click on the Sign Up option to set up your account. There is a unique access code for Alberta producers. The code can be found by visiting the "Water Issues and Treatment" thread on the Producer Portal Forum, or you can contact Carley or Jenna at the EFA office.

You may share the app's generated results (PDF files) with your service providers. However, please only use the access code for your own purposes and do not share it with other folks, as the number of users from each commodity is being tracked and there is a different mechanism in place to provide access to the app for industry partners.








