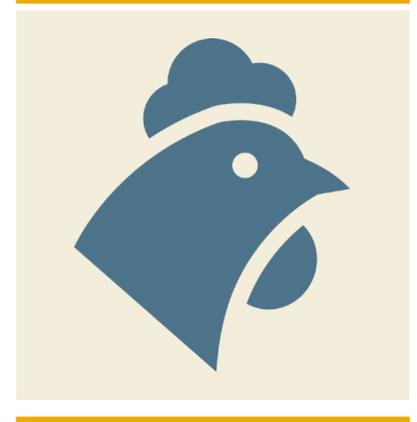

➤ Whole Barn Gassing E-Learning Modules Available

Whole barn gassing is an increasingly common method of end of lay depopulation in Alberta. If done correctly, the ability to euthanize birds in their home environments, without exposing them to the catching process, has significant welfare benefits. However, depopulation of barns using carbon dioxide gas, whether for routine depopulation or an emergency, is extremely dangerous. Given the number of factors that need to be considered for human safety, bird welfare, and equipment protection EFA has worked with experts to develop e-learning for farmers.

The content can be accessed on the producer website under Healthy Birds (Humane Endings). It includes procedures, safety considerations, and operational considerations. There are several downloadable resources to support producers choosing this method.

➤ AFAC LCC REMINDER



► Nielsen Update

The Nielsen retail sales data is available up to December 26th, 2020, which is effectively the year-end stats for last year. The stats indicate that in the latest 4-week period 3.6 million dozen eggs were sold in Alberta; a 3.7% increase from the previous 4-week period (ending November 28th), and a 3.6% increase in sales compared to the same period in 2019.

Nielsen retail sales in the last 52 weeks are up 7.2% over the previous 52 weeks in Alberta, to 44.2 million dozen eggs. Regular white & brown eggs have seen the largest sales growth; a 7.9% increase over the previous 52 weeks, to 37.6 million dozen eggs (85.1% of the total eggs sold in Alberta).

As a reminder, additional Nielsen trend data that is updated approximately every four weeks is available on the producer website.

► 2021 Amendments to the Start-Clean, Stay-Clean Farmer Guidelines Manual


The Start Clean – Stay Clean® program is continuously evolving as a result of emerging experiences, science-based research, technical advancements, and government regulations. On August 7, 2020, Egg Farmers of Canada (EFC) approved several amendments to the SC-SC™ Program which became effective January 1, 2021. To reflect these amendments, the SC-SC™ Farmer Guidelines Manual has been updated to include the changes to manure removal equipment, mortality disposal, facility hygiene, pullets sourced from SC-SC™ participants, humidity levels in refrigerated storage, no spillage of feed around the bins, and on-farm feed mixing.

The updated pages for the SC-SC™ Farmer Guidelines Manual as well as the full version of the updated Manual have been posted to the producer website at SC-SC™ Layers (Farm Programs). EFA Field Service Coordinators (Dave Lastiwka and Murray Minchin) will be delivering hard copies of these updated pages in their upcoming field visits.


► MEFR Update

The COVID-19 pandemic continues to cause unexpected market volatility, which has recently seen an increase in demand. As of February 2nd, 2021, the Modified Early Fowl Removal (MEFR) program is in a holding pattern, which will continue for a period of at least 2 weeks, with EFC not accepting any new applications. The MEFR program has not been cancelled and any approved applications currently in process will continue.

EFC and value chain partners are monitoring the situation closely. EFC and the provincial boards will make a further determination at the end of the 2-week period.

➤ **Need Safety Data Sheet?**

In the January issue of EggNotes we talked about the purpose and importance of having a Safety Data Sheet (SDS) for all hazardous substances on your farm.

We would like to flag that for farmers who purchase supplies from UFA, SDS documents are available online for download. These can be a little tricky to find! Navigate to: <https://coop.ufa.com/environment-health-safety>

At the bottom of the page you will find a button “MSDS”. This will bring you to a list of downloadable sheets searchable by product name and/or manufacturer.

➤ **Workers Compensation Board Yearly Statistics**

The Workers Compensation Board has released their annual statistics on the number of claims, types of injuries, cost of compensation etc. for the Alberta poultry and egg sector. Impressively, poultry and egg producers had an overall decrease in the number of injuries, their severity, and claim cost for 2020. The results indicated that the two types of incidences to cause injury were falls and roadside accidents, with injuries being sustained to the head and hands/wrists. The age groups involved in these incidences were between 19 to 26 years or over 58 years. For further details visit the producer website at Farm Safety (Healthy Farms).

➤ **AgSafe Alberta Webinar Series**

AgSafe Alberta is hosting a series of webinars on farm safety with topics including legislation, culture and how to bring the two together. Webinars include:

- **Getting Started** – February 23/March 23 – How to build a safety plan
- **Being Right or Being Regulated?** – March 9 – Reg Steward brings regulation and culture all home by combining his two decades of safety and boots in the barnyard experience to help view safety as a way of doing business: by doing the right things for the right reasons

➤ **CPTPP Mitigation**

As a follow-up to the CPTPP Mitigation update article in the December 2020 issue of EggNotes, the federal government has confirmed that the \$691 million of announced funding to support innovation and growth for the egg and poultry sector will be utilized for investment and market develop programs. Representatives from the poultry and egg producers are working closely with the government to develop these programs. EFA will continue to provide updates to Alberta egg farmers as they become available.

➤ Research Update

In 2020 EFA was proud to launch our first ever research Call for Proposals. Researchers were invited to submit applications in areas that addressed targeted industry priorities. Funding was made available to focus on specific priority areas benefiting Alberta's egg farmers. The targeted priority areas were established in 2019 by farmers in consultation with researchers and value chain partners. Four projects were approved for funding:

- Dr. Karen Schwean-Lardner: Effect of LED flicker on pullet welfare, health, and production and further impacts on hen performance, egg production, and egg quality
- Dr. Karen Schwean-Lardner: Effects of increasing dietary omega-3 polyunsaturated fatty acid supplementation to 3% during bone development in pullets
- Dr. Dongyan Nui: Surveillance of egg yolk peritonitis (EYP) and causative Escherichia coli in egg farms, Alberta
- Dr. Anatoliy Trokhymchuk: Developing a novel, rapid tool for non-typhoidal Salmonella detection and risk assessment in Western Canadian poultry



► From Your Research Committee

This is a new regular column in EggNotes written by a member of EFA's Research Committee. It is intended to provide Alberta's egg farmers information about what is happening in Alberta poultry research. This article was written by Susan Schafers.

Recently, I was on a Zoom meeting with the University of Alberta's Poultry Innovation Partnership (formerly known as the Poultry Research Centre). During a presentation, a timeline of changes in the Canadian and American poultry industry was presented and I was struck by the amazing improvements that have taken place in our industry.

Research and innovation have played such an important role in our industry. Within one or maybe two generations, we have seen egg production move from 151 eggs/year in 1945 to 276 eggs/year in 2010. Now the standard is well over 300 eggs per year!

I also noted how much change there is in the advancement of technology and in mechanical equipment., such as cages and grading equipment. We went from hand gathering and home coops to indoor production with cages that advanced the health and welfare of our hens. With more advancement and research, we are developing breeds and equipment that allow us to raise large numbers of hens indoors while managing and respecting the hens' welfare needs.

Our research dollars are well-spent knowing that we are advancing all aspects of our poultry industry!

► **Filed Plan Regulation Amendments**

Please be advised that the EFA Plan Regulation Amendments have been approved by the Minister, filed and are now officially in force and effect. As a summary, here are items that have been changed or updated. The new Plan Regulation is available on our producer website as soon as the Plan Regulation is posted to the Alberta Queen's Printer website.

- **Commercially Sensitive Information**

The Board may refuse to allow access or limit access by a registered producer to books and records, if the Board is of the opinion that access would reveal commercially sensitive information about a producer, processor or other person.

- **Terms of Office**

Directors are now eligible to serve 3 consecutive 3-year terms.

- **Director Eligibility**

Modifications have been to the definition of family member. Processors, designated representatives of processor, member of the Board, or someone otherwise involved directly or indirectly in the control management or direction of processor or an organization that processes eggs for other producers are not eligible to serve on the Board. This also extends to family members family members defined as spouse, adult interdependent partner, child, parent, sibling, son-in-law, daughter-in-law, father-in-law, mother-in-law.

► **“In The Know” Free Online Mental Health Training for Farmers**


