# **Nielsen Update**

The Nielsen retail sales data is available up to August 18, 2018, and indicates that in the latest 4-week period 3.02 million dozen eggs were sold in Alberta; a 1.4% decrease from the previous 4-week period (ending July 21st), and a 5.1% increase in sales compared to the same period in 2017.

Nielsen retail sales in the last 52 weeks are up 4.8% over the previous 52 weeks in Alberta, to 41.2 million dozen eggs. Specialty eggs (excluding Omega-3) have seen the largest sales growth; a 6.5% increase over the previous 52 weeks, to 3.6 million dozen eggs (8.7% of the total eggs sold in Alberta).








# Why Wet Wash?

Imagine you are cleaning your kitchen floor. You begin with a sweep – this removes the bulk of the dirt, but there is still material stuck to the floor. To get a truly clean floor you must bring out the soap and warm water.



Sweeping is like dry cleaning, it only removes the bulk of organic material. In layer and

pullet barns there is still organic materials stuck to the facility walls, floors, ceiling and equipment following dry cleaning. The material stuck to layer and pullet barns is made up of fecal material, dust, egg material, feathers and biofilms (that you often can't see) that can contain pathogens.

Biofilm protects bacteria from their environment and disinfectants. For disinfectants to be effective the biofilm and all organic material stuck to facility and equipment surfaces must be removed. Disinfectants will not work if they don't come in contact with target organisms. The detergent (or soap) used while washing is capable of breaking down biofilm and organic material for removal in the wash water. Dry cleaning alone is of little or no use in fighting pathogens or disease if it is not followed by wet cleaning prior to disinfection. To effectively clean out contaminants and pathogens from your barn, the best practice is to wet wash between flocks.

# **Update to Salmonella Sampling Protocols**

Egg Farmers of Alberta is amending our Salmonella sampling protocols, removing the requirement to test all flocks on farm when one flock needs to be tested. When more than one flock is housed in a single production facility, all flocks within the facility will continue to be tested. As much as possible, EFA will continue to schedule SE sampling on farms so that as many flocks as possible can be sampled within the sampling time frames. This change will be most evident on farms that have an above average number of pullet barns and/or egg layer barns and flocks don't align for sampling at the same time.








# **Changes to SC-SC Program effective January 10, 2019**

Egg Farmers of Canada is currently reviewing the SC-SC on farm food safety program and as a result, is making the following changes effective January 10, 2019:



Element	Change & Reason
Sanitary outer clothing and a change of boots are required before anyone enters the restricted area of the production unit	The use of foot-baths, spray disinfectants and disinfectant mats will no longer be an acceptable alternative to changing boots when entering the restricted area. This change is being made because boot change alternatives require high maintenance when used correctly and can be a source of biological pathogens when used incorrectly. Full points will be granted only if boots are changed before entering the restricted area.
Cleaning and disinfecting the laying facility – Dry-clean SE test	Should a farmer choose to dry-clean, an SE test will be conducted 8 weeks prior to re-population to ensure that the test results are outcome-based.  This test dry-clean SE can be combined with the late-lay SE test in the previous flock. Should the test results be SE positive, the barn must be wetwashed and disinfected prior to re-population.  **Note, wet cleaning is strongly recommended. Please see the article Why Wet Wash? to learn more.

Element	Change & Reason
Bonus Points Section	Thee following bonus point elements will be removed from the SC-SC program:  a) All in/all out in each production unit b) Changing footwear, or using foot dips or spraying disinfectant on footwear between different age lay facilities in the same production unit.
	These bonus point questions have been removed to prevent misrepresentation of the final audit scores.
Cats, dogs and other animals are denied access to the production unit	Cats may be used in conjunction with a comprehensive pest control management system. If a cat is used in the production unit as an additional method of pest control, the following guidelines will apply:
	i. Cat may be male or female, but must be spayed/ neutered ii. Cat litter must be swabbed for SE once annually, at a minimum iii. Cat must have access to their own food, water, and litter iv. Cat must not have access to the outdoors
	If cats are used an additional method of pest control, and all of the above guidelines are met, the farmer will receive equivalency points for the element.

## **New Fee for Non-Conformance**

Although it happens very rarely, there have been cases where farms score below the mandatory requirements in the Animal Care and SC-SC programs year after year. These farms receive significant support and follow-up to ensure that their corrective actions are addressed and that they meet industry standards within their corrective action deadlines. Following review of these cases, the Production Management Committee recommended a new policy that will see those farms that are below 90% on the Animal Care or SC-SC program for three years or more in a row will be charged a non-refundable fee of \$250.00 payable to the Board. This fee will be used to help cover the additional work related to following up on corrective actions.

# Building a new barn or renovating?

If you are planning to build a new barn or renovate your production facility, we encourage you to set-up a hen housing meeting with Egg Farmers of Alberta. During the meeting, we provide valuable information, not just about hen housing, but about quota, biosecurity and environmental considerations. # **CEIRA Announces Avian Influenza Coverage**

CEIRA is pleased to announce Avian Influenza (AI) coverage beyond compensation from the Federal Government's Health of Animals Act. The Health of Animals Act only provides compensation for the value of birds up to the age birds are removed. CEIRA's coverage was developed to address losses not covered by the Health of Animals Act as noted in the chart below. Al coverage is automatically combined with your existing SE coverage. The based premium increases from 25 cents to 28 cents per chick effective September 17, 2018.

# Notice on Interim Housing Standards & Housing Certificates for Furnished & Loose Housing

In July, EFC approved their Measuring Methods for Non-Conventional Housing. As of September 10th, EFC will begin coordinating farm visits to measure facilities with furnished or loose housing systems. Following verification of the measurements, hen housing certificates will be issued. EFA is working to determine how the National measuring protocols differ from the provincial protocols, and the potential impact on farmers. A copy of EFC's Measuring Protocols is available for your reference on the producer website on the Animals Care Program page.

At EFC's summer meeting, their Board also approved Interim Housing Standards. As of January 10, 2019 Egg Farmers of Canada will begin auditing farmers on these standards,

that reflect the 2017 Code of Practice requirements. The aim of these audits is to help farmers identify where facilities are not meeting 2017 Code requirements prior to the release of the re-developed Animal Care Program. The Interim Housing Standards will be audited in a separate evaluation form to the Animal Care Program Rating form and will not impact the Animal Care Program score. Corrective Actions will be issued following the interim housing assessment. While CARs will be managed in the same manner as the Animal Care program, there is no mandatory score or penalties for non-completion of interim housing CARs.



Alternative housing systems will not receive an Interim housing standard assessment until they have had their measurements verified by EFC and have received a hen housing certificate.
